In consideration of the camper's enrollment and the payment of the appropriate fees, upon acceptance, Stagedoor Manor agrees to reserve a place for the summer of 2009.

**REFUND POLICY:** Once a session begins, there are no refunds of any kind for late arrivals, early withdrawals, non-arrivals, homesickness, or dismissal. All fees are completely refundable **UPON WRITTEN REQUEST** prior to January 15, 2009. Thereafter the deposit is non-refundable. Before February 15, 2009, the 2nd payment is completely refundable **UPON WRITTEN REQUEST**. Thereafter, there will be NO refunds. Reducing the number of sessions before February 15, 2009 will be done by written request. After February 15, 2009, there will be a \$500 charge per session dropped. After April 1, 2009, there will be no refunds for sessions dropped. All requests to switch sessions must be made in writing. We will do our best to accommodate such requests.

Stagedoor Manor reserves the right to refuse admission to any camper for whom full payment has not been made in accordance with the above schedule. In such event, no refund will be made and Stagedoor Manor shall have the right to recover reasonable attorney's fees and costs for all unpaid amounts. This contract constitutes the full understanding of the parties, hereto and cannot be modified except in writing signed by both parties hereto. The venue of any dispute under this agreement or otherwise between parties shall be the Fallsburg, New York Municipal Court or the County/State Court of Sullivan County, New York.

**Because we want to provide the best possible experience for every camper, Stagedoor Manor has developed policies designed to ensure a safe, productive and friendly camp community. In order to do so, we ask all of our parents and campers to read the Parent-Camper Handbook (which is available online) and agree to the policies outlined on this contract. Your signature on this application indicates your agreement with these policies.**

1. No camper may use or have possession of any illegal drug while at Stagedoor Manor, either on camp property or any excursion outside of camp.
2. All medications, including over-the-counter drugs and vitamins, must be kept in the infirmary. Inhalers, epi-pens, and other life sustaining items may be kept in the camper's room with the nurse's permission. Campers and staff may not give any medication to another camper or staff member.
3. No camper may use or have possession of alcohol while at Stagedoor Manor, either on camp property or any excursion outside of camp.
4. No camper may use or have possession of cigarettes, cigars, or other tobacco products, cigarette lighters, or matches. The smoking ban is in effect for campers on all camp property including the road in front of camp and any excursions outside of camp.
5. Violent action to other people, animals, property, or to yourself is prohibited. You may not physically strike anyone under any circumstance. Campers, staff, and parents agree to respect all members of the community and will refrain from abusive or intimidating language or mistreatment of any kind.
6. Campers are strictly prohibited from engaging in sexual activity or excessive displays of affection.
7. Campers agree to remain on camp property, leaving only as part of a regularly scheduled camp trip, and with Staff supervision, unless prior arrangements have been made.
8. Campers agree not to deface or destroy camp property. This includes graffiti on the walls of living spaces and other buildings. Parents will be held financially responsible for any damages.
9. Campers agree not to have exposed food or drink in their rooms in order to keep insects and other critters out of the buildings and for health and sanitation reasons.
10. Campers must wear shoes in the buildings and on the grounds.
11. Gum chewing is not permitted at camp.
12. Campers agree to the cell phone policy as stated in the Parent-Camper Handbook, and campers and parents agree to all of the other provisions of the Parent-Camper Handbook.
13. There will be no visitation in opposite-sex living spaces.
14. Stagedoor Manor, its officers, directors, members, and employees shall not be responsible for camper's clothing or personal possessions lost or damaged by theft, laundry, fire, malicious mischief, or otherwise. Stagedoor Manor specifically advises against bringing jewelry, cash or valuables to camp.
15. Campers are housed (3 to 6 campers to a room) in facilities which were formerly a hotel, and, therefore, different from most camps. It is specifically cited, however, that Stagedoor Manor is a camp and not a hotel and should be considered accordingly.
16. The undersigned understands that part of the training program may include performances before a paying public, appearing in taped shows and in pictures and video which is shot in conjunction with the program (collectively "performances"). The undersigned hereby gives permission for the camper to take part in the performances both on and off campus with neither extra fee nor compensation. The camper may travel by camp vehicle or via hired carrier. As further consideration for the enrollment of the camper, the undersigned hereby grants to Stagedoor Manor the right to use any performance, photograph, film, or videotape in which the camper appears for broadcast, publication, advertising or exhibition.
